SCHEDULE

TRANSPORTATION

Transportation is the responsibility of the parent or guardian. Late pick ups may result in dismissal from the class without a refund. Students enrolled in an enrichment class should not wait at the school. Please supervise your child or return when the classes begin.

SUPERVISION

Child supervision is NOT provided between school end time and enrichment program start time.

Additionally, supervision will NOT be provided after enrichment class end time. Cupertino Recreation and CUSD staff are NOT responsible for monitoring child activity after he or she is released from classes.

CLASSROOM BEHAVIOR

The instructor will establish rules for classroom behavior that ALL STUDENTS must follow. Students who disrupt classroom lecture will be asked to leave the class WITHOUT a refund.

REGISTRATION

Pre-registration is required for all classes. For more information about registration, please review pages 13-14. The registration form is located on page 12.

ATTENDANCE

Unless cancelled by the contractor, missed classes cannot be made up and refunds WILL NOT be issued. Attendance is limited to participants ONLY.

DISABILITIES

If your child has a disability that requires special accommodations in order to participate, please let staff know when you register.
