

The grounds for the proposal recall are as follows:
The undersigned voters propose that Councilmember Barry Chang be recalled from office
due to his pattern of abusive and dishonest behavior toward the public and other council members.
Barry Chang has failed to fulfill his fiduciary duty to Cupertino citizens. He started to run
for State Assembly only six months after being sworn-in, and used his position in Cupertino to
solicit large campaign contributions from developers, construction companies and real estate

Barry Chang has repeatedly disgraced the City of Cupertino, by personal attacks against residents in council meetings and in the State of the City address. Even when corrected by other council members and staff members, he persisted in these defamatory comments and blatant lies without remorse or contrition.


