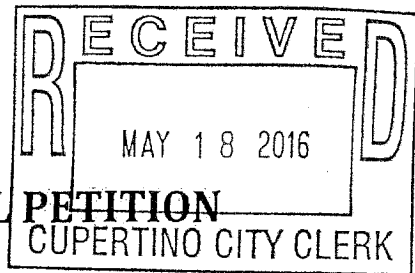

NOTICE OF INTENTION TO CIRCULATE RECALL PETITION

TO THE HONORABLE Councilmember Barry Chang :

Pursuant to Section 11020 of the California Elections Code, the undersigned, registered qualified voters of the City of Cupertino, in the State of California, hereby give notice that we are the

The grounds for the proposal recall are as follows:

The undersigned voters propose that Councilmember Barry Chang be recalled from office due to his pattern of abusive and dishonest behavior toward the public and other council members.

Barry Chang has failed to fulfill his fiduciary duty to Cupertino citizens. He started to run for State Assembly only six months after being sworn-in, and used his position in Cupertino to solicit large campaign contributions from developers, construction companies and real estate brokers that will benefit from his actions on the City Council.

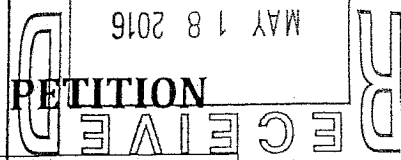
Barry Chang has repeatedly disgraced the City of Cupertino, by personal attacks against residents in council meetings and in the State of the City address. Even when corrected by other council members and staff members, he persisted in these defamatory comments and blatant lies without remorse or contrition.

Barry Chang has abused his position as mayor. He called a special meeting without proper justification, purposely circumventing the Brown Act, to change the ballot label for the Cupertino Citizen's Sensible Growth Initiative, brazenly ignoring the recommendations of the city's own attorneys to conform to the California Election Code, and taking the recommendation of a developer's attorney instead.

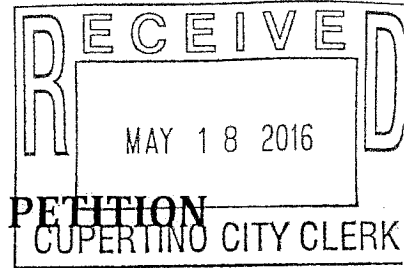
