NOTICE IS HEREBY GIVEN that the City of Cupertino City Council will consider an additional citywide Interim and Urgency Ordinance extending Urgency Ordinance No. No. 16-2153: “Interim Urgency Ordinance establishing a Moratorium on Non-Medical Marijuana Dispensaries, Marijuana Cultivation Facilities, Commercial Cannabis Activities and Marijuana Transport and Deliveries within the City pending completion of an Update to the City’s Municipal Code.” This additional Interim and Urgency ordinance will extend the moratorium and prohibitions on non-medical marijuana uses and cultivation as adopted by the City Council on October 18, 2016 with adoption of Ordinance No. 16-2153. Steps have been taken to alleviate the urgency as state decriminalization of non-medical marijuana is on the November 8, 2016, ballot as Proposition 64. If Proposition 64 passes and upon reviewing the steps the state may take to regulate non-medical marijuana and associated businesses, staff will bring forward a regular ordinance. In the interim, it will be necessary to extend the existing urgency ordinance to facilitate the orderly adoption of zoning code amendments, as permitted by law.
