The City of Cupertino is seeking public comment on the proposed amendment to the City's 2008-09 Annual Plan. The City has been notified by the Department of Housing and Urban Development (HUD) that it will receive a supplemental allocation of \$105,000 in CDBG funds as a result of the passage of the American Recovery and Reinvestment Act (ARRA). The City's Annual Plan describes how the City Plans to use the allocation of supplemental ARRA funding. Initial guidance from HUD indicated that these supplemental CDBG funds are to be used by the City in a manner consistent with the needs identified in the City's adopted five year Consolidated Plan. The current Consolidated Plan was adopted in March 2006 and is in effect through June 2010. The Consolidated Plan is available for review from the City of Cupertino Community Development Department, Housing Division at the address below. The City of Cupertino plans to allocate its supplemental ARRA CDBG funds towards energy conservation efforts in rehabilitation. Citizens and groups are encouraged to submit written or verbal comments regarding the proposed amendment to the Annual Plan during the public comment period. The public comment period begins with the publication of this notice and ends after no less than seven days. Public comments received at the public hearing on June 2, 2009, or during the seven day public comment period will be considered for incorporation into the amended Annual Plan document. The City Council will hold a public hearing to receive public comment and to consider adopting the amended 2008-09 Annual Plan during a regularly scheduled meeting at 6:45 p.m. on Tuesday, June 2, 2009 in the Community Hall at Cupertino City Hall, 10300 Torre Avenue, Cupertino, CA 95014. All interested parties are invited and encouraged to attend the June 2, 2009 public hearing. Persons needing special assistance under the Americans with Disabilities Act should call at least 48 hours prior to the public meetings to ensure their needs can be appropriately accommodated.
