

RESOLUTION NO. 18-081

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CUPERTINO
APPROVING THE REGNART CREEK FEASIBILITY STUDY AND DIRECTING STAFF
TO ESTABLISH A BUDGET AND PROCEED WITH DESIGN AND ENVIRONMENTAL
REVIEW OF THE REGNART CREEK TRAIL, AND AMENDING THE FY 18/19 ANNUAL
OPERATING BUDGET TO APPROPRIATE \$380,000 TO THE CAPITAL IMPROVEMENT
FUND FOR THIS PURPOSE**

WHEREAS, the Regnart Creek Trail is consistent with *General Plan: Community Vision 2015-2040* Policy M-1.3: Regional Trail Development, Policy M-2.3: Connectivity, and Policy M-5.3: Connections to Trails; and

WHEREAS, the Regnart Creek Trail is identified within the City of Cupertino 2016 Bicycle Transportation Plan as a significant element of the Cupertino Loop Trail, rated in the Plan as high utility, high feasibility, and high priority; and

WHEREAS, the Regnart Creek Trail is identified within the City of Cupertino 2018 Pedestrian Transportation Plan as a Tier 1 high priority project, rated in the Plan as providing high connectivity to schools, parks and the library; and

WHEREAS, Community outreach has occurred at the following meetings and workshops, in which support was considerable, but concerns were raised regarding privacy and safety:

- Public Walkshop, November 18, 2017
- Community Meeting #1, January 22, 2018
- Community Meeting #2, April 23, 2018
- Lazano Lane and De Palma Lane Residents Focused Meeting, May 23, 2018; and

WHEREAS, the Santa Clara Valley Water District (SCVWD) has been involved and provided input throughout the Feasibility Study development process; and

WHEREAS, Conceptual project plans have been developed to best address concerns raised during the outreach process and the needs of SCVWD.

WHEREAS, an adjustment to FY 18/19 Capital Improvement Fund is necessary to appropriate an additional \$380,000 for this purpose;

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Cupertino hereby:

- Approves the Regnart Creek Trail Feasibility Study
- Directs staff to prepare design documents and conduct environmental review of the project
- Directs that projects designs shall address concerns of property owners abutting the trail, to the extent feasible; and
- Establishes a budget within the City's Capital Improvement Program to implement the design and environmental review of the Regnart Creek Trail
- This Resolution No. 18-081 is adopted, amending the FY 18/19 Capital Improvement budget to appropriate \$380,000 for this purpose.


