Draft guidelines are no available at this time but are anticipated to be more definitive that currently published guidelines available to-date. 2. Bridge Locations	
a. JC presented and explained four alternative bridge locations and a	ssociated



complexities for the proposed western bridge.

- i. Alternative #1
 - Requires tree removal and associated regulatory permitting
- ii. Alternative #2
 - Utilizes a 22% slope between the concrete ramp and the bridge. This alternative is not acceptable to VW.

iii. Alternative #3

- Regrading within top of bank would require regulatory permits.
- Bridge proximity to the concrete ramp is a safety concern and can impede maintenance vehicle access.
- iv. Alternative #4
 - Requires modification to the back fence of the baseball diamond.
 - VW is agreeable to modification of the existing chain link fence to accommodate bridge improvements in this alternative.
 - Preferred alternative by VW
 - No known regulatory permitting requirements.

3. Bridge Cross Section

- a. HMH obtained confirmation on the following design considerations:
 - i. Freeboard shall be 12" above top of bank proposed.
 - ii. Clear width between bridge truss and property fence shall be 12'.
 - iii. Bridge skew shall be as minimal as possible.
 - iv. 15' along Wilson Park and the baseball fields is owned by VW.
 - v. Design considerations for the western bridge will apply to the eastern bridge.

4. Trail Cross Slope

- a. The trail is proposed to slope toward the creek to match existing conditions.
- b. Underdrains within the porous pavement trail section will tie into existing outfalls to the Creek. No new outfalls are proposed.
- c. Slotted drains may be installed to capture rainfall in significant rain events.
- 5. Railing
 - a. Creek side railing will be limited to areas adjacent to steep side slopes (i.e. near culverts) and bridge crossings.

6. Sample Agreements

- a. Once City and VW maintenance responsibilities and obligations are agreed upon, the responsibilities and obligations will be specifically described in a Joint Use Agreement (JUA) that will need to be accepted by the City Council and VW Board of Directors.
- b. The JUA shall encompass all portions of VW fee title right of way, including the portion of the trail within VW right-of-way located adjacent to Wilson Park and replace the existing JUA near De Palma Lane.
- c. JUA shall include detour plans in the event of a trail closure.

7. Project Schedule

- a. 65% Construction Documents and the Environmental Document will be submitted to City for review end of April/beginning of May.
- b. Regnart Creek Trail Public Outreach Meeting is scheduled for April 24th at 6:30 p.m. VW is encouraged to attend.
- c. City of Cupertino Council Meeting scheduled for May 21st. VW is encouraged to attend.
