| 4. Relocation of VW Access Ramp   | _   |

Cody Houston (CH) and Sue Tippets (ST) indicated that ramp<br>relocation may not be allowed under SMP permits. internally and discuss with regulatory agencies, if needed, to determine applicability.

#### 5. Location and Structural Aspects of Wilson Park Bridge

a. JC summarized options to relocate the eastern bridge to the location of the current maintenance ramp which will be filled. The location of the bridge will consider existing vegetation, crane access and adjacent properties.

#### 6. Property Encroachments @ Wilson Park and Library Field

- a. JC and RL indicated that it would be very difficult for the City to relocate the fence abutting City Hall due to the existing trees which occupy the park strip between the right-of-way and the parking lot.
  - i. Yvonne Arroyo (YA) indicated that VW would likely not enforce this requirement given the significant impact to the trees.
- b. YA indicated that along Wilson Park, VW is seeking to regain property to replace the property which is currently inaccessible due to the baseball diamond fence.
- c. RL indicated that the land may not be a 1:1 ratio. CH indicated additional room adjacent to the replaced ramp that provides better staging and access may provide an adequate land swap.

#### 7. Lozano Lan Screening/Fencing

- a. JC indicated that Gary Wong, HOA President for the Lozano Lane residents had indicated that the properties fronting the trail in this area expressed interest in an opaque sound wall. RL inquired whether VW would permit this wall to be constructed on VW land approximately 1' from the property line at Lozano Lane.
  - i. Sue Tippets (SU) indicated that, as discussed at previous meetings structures and other obstructions on VW land would not be permitted. A feature which straddled the property line whose footings encroached into VW may be acceptable.

#### 8. De Palma Lane Delineation

a. City exploring a Woonerf concept which would create a shared space for bikes and peds.

#### 9. Joint Use Agreement

- a. City is exploring Grant applications which have stipulations regarding renewable / irrevocable use of the corridor. VW's typical term is 30 years and has been sufficient for other grant applications.
- b. Before the JUA can go to VW's Board, CEQA clearance must be completed.

Cody Houston (CH) and JC to field walk the potential site to determine possible footprints.
