On Tuesday, October 20, 2020 at 6:45 p.m., the City Council of the City of Cupertino will conduct a public hearing to consider Municipal Code Amendments to Cupertino Municipal Code Chapter 10.48 Community Noise Control to consider regulations for Leaf Blowers. Application No(s): MCA-2020-002; Applicant(s): City of Cupertino; Location: Citywide.

At a regular meeting of the Planning Commission on Tuesday, September 22, 2020, the Planning Commission's motion to recommend that the City Council approve the Municipal Code Amendments failed with a vote of 0-4-1 (Saxena absent) per Resolution #6910.

In accordance with Governor Newsom's Executive Order No. 209-20, this will be a teleconference meeting without a physical location.
