CITYWIDE NOTICE OF PUBLIC HEARING FOR AMENDMENTS TO THE CUPERTINO MUNICIPAL CODE

The public is invited to attend a City of Cupertino City Council meeting on **Tuesday, February 16, 2021 at 6:45 p.m.**, at which time the City Council will conduct a public hearing to consider proposed amendments to add a new section to the Cupertino Municipal Code that will include Vehicle Miles Traveled (VMT) standards, used to determine transportation impacts under CEQA (California Environmental Quality Act), a change required by California Senate Bill (SB) 743.

At a regular meeting of the Planning Commission on January 26, 2021, the Planning Commission recommended approval of a new Ordinance for Vehicle Miles Traveled standards by a vote of 4-0-1 (Saxena absent) per Resolution #6917.

In accordance with Governor Newsom's Executive Order No-29-20, this will be a teleconference meeting without a physical location. Members of the public will be able to observe and address the meeting telephonically or otherwise electronically from the City's website through procedures that will be detailed in the published meeting agenda.
