In May 2018, the County released the first of ten annual reports to provide the community with information and updates related to the Supportive Housing System, 2016 Measure A Affordable Housing Bond activities, progress towards the goals of the Santa Clara County Community Plan to End Homelessness, and efforts to improve client outcomes in the County. - 8. What are we doing for low-income seniors?

The City funds the following services for seniors:

- Catholic Charities of Santa Clara County Long-Term Care Ombudsman
- Senior Adults Legal Assistance (SALA) Legal Assistance to Elders
- 9. How can I find more data on local homelessness trends and causes? Every two years, communities across the country conduct comprehensive counts of their homeless populations to measure the prevalence of homelessness. The County of Santa Clara, the City of Cupertino, the other cities in Santa Clara County, and the Continuum of Care worked in conjunction with Applied Survey Research (ASR) to conduct the Santa Clara County Homeless Census and Survey. The 2019 comprehensive report of this effort, previous reports, and other related documents, is available here. While the COVID-19 pandemic precluded many communities, including ours, from conducting a 2021 count, you can expect a report on the 2022 census and survey this summer.
- 10. What is the role of the Santa Clara County Community Plan to End Homelessness and where can I learn more about it? The 2020–2025 Santa Clara County Community Plan to End Homelessness guides the County, cities, nonprofits, and other community members in making decisions about funding, programs, priorities, and needs. This County-level plan was adopted by the Cupertino City Council in December 2020.

11. Who is Homebase?

The City selected Homebase as the lead consultant for the City Plan to End Homelessness. Homebase is a non-profit dedicated to building community capacity to prevent and end homelessness. As a facilitator, community partner, and nationally-recognized technical assistance provider, we combine deep knowledge of the realities of homelessness, including its causes and solutions, with practical experience designing and implementing programs and systems that help people regain housing, improve health and wellness, and reclaim their dignity.
