Rules for Riding in a Group

Ride on the right side of the road

Make sure your child does not ride into oncoming traffic.

Avoid the door zone

Stay at least 3 feet from parked cars to avoid any doors that open.

Create space between riders

Don't let your front wheel pass the back wheel of the person in front of you.

At signalized intersections, obey the signal

STOP if the light is red, yellow, or "stale" green (it's been green so long that it will turn yellow any second), even if it separates you from your group.

Use hand signals

Signal right, left, or stop before turning or stopping.
