1. BID SUBMISSION: The City uses a two-part Bid process with Bids in Envelope "A" and Statements of Qualification and Financial information in Envelope "B". City will accept Envelope "A" and Envelope "B" before 2:00 p.m. on May 7, 2015 –in the City Clerks Office. Bids will be publicly read at 2:10 p.m. in Cupertino Community Hall located at 10350 Torre Ave. City's representative will call out the designated time in the Office of the City Clerk, 10300 Torre Avenue, stating that the period for accepting Bids is closed. The Bid opening will be in accordance with procedures set forth in Document 00200 (Instructions to Bidders).

- 3. **STATEMENT OF QUALIFICATIONS:** Each Bidder shall be required to submit a "Statement of Qualifications" in accordance with Document 00200 (Instructions to Bidders) and Document 00450 (Statement of Qualifications for Construction Work).
- 4. **DESCRIPTION OF THE WORK:** Work includes providing all labor, materials, tools and equipment necessary for furnishing and installing approximately 2330 LF of storm drain and 570 LF sanitary sewer pipelines and associated facilities, including but not limited to 70 LF of 40 inches diameter steel casing, storm drain manholes, sewer manholes, sewer laterals, within the limits of a public roadway, and approximately 80 LF of curb and gutter and sidewalk replacement, restrictor at manhole outlet, back water valve, property line clean outs, and abandonment/removal of storm drain culvert, sanitary sewer mains and manholes. Installation includes traffic control, excavation of trenches, laying pipe materials and installation of structures, backfill trenches, curb, gutter and pavement restoration and other pertinent work as necessary to construct the project as shown on the approved plans and specified in the project specifications
- 5. **CONTRACT TIME:** All storm Drain works on McClellan Road <u>must be</u> completed before August 17, 2015. All other work (both storm and sanitary sewer system) on September

Drive and Festival Drive shall be completed before October 30, 2015 in accordance with contract requirements, and project completion. It is anticipated that City Council will award the contract on May 19, 2015 with a notice to proceed to be issued on or before June 15, 2015.

- 6. **REQUIRED CONTRACTOR'S LICENSE:** A California Class "A" General Engineering Contractor or Class "C-34" Pipeline Contractor, contractor's license is required to Bid this Contract. Joint ventures must secure a joint venture license prior to award of this Contract. Removal, handling, and/or disposal of hazardous materials may, by law, require hazardous substance removal certification by the Contractor's State License Board.
- 7. **PREVAILING WAGE LAWS:** The successful Bidder must comply with all prevailing wage laws applicable to the Project, and related requirements contained in the Contract Documents.
- **8. INSTRUCTIONS:** Bidders shall refer to Document 00200 (Instructions to Bidders) for required documents and items to be submitted in sealed envelopes to City Clerk's office, as well as applicable times for submission.
- 9. **SUBSTITUTION OF SECURITIES:** City will permit successful Bidder to substitute securities for retention monies withheld to ensure performance of Contract, as set forth in Document 00680 (Escrow Agreement for Security Deposits in Lieu of Retention), in accordance with California Public Contract Code, Section 22300. By this reference, Document 00680 (Escrow Agreement for Security Deposits in Lieu of Retention) is incorporated in full in this Document 00100.
- 10. **PRE-BID CONFERENCE:** City will conduct a Pre-Bid Conference at **10:00 AM on Tuesday, April 28, 2015** at the site, the intersection of McClellan Road and September Drive in the City of Cupertino. Any Bidder wishing to investigate subsurface conditions at the site must schedule such a visit with the City in accordance with Document 00200 (Instructions to Bidders).
- 11. **PROCUREMENT OF BIDDING DOCUMENTS:** Bidders may examine a complete hard-copy set of bid documents at the City's Public Works Department, City Hall, 10300 Torre Avenue in Cupertino.

- 12. **BID PREPARATION COST:** Bidders are solely responsible for the cost of plan and specification printing and preparing their Bids.
- 13. **RESERVATION OF RIGHTS:** City specifically reserves the right, in its sole discretion, to reject any or all Bids, or re-bid, or to waive inconsequential deviations from Bid requirements not involving time, price, or quality of the Work.
- 14. **PORTION OF WORK PERFORMED BY THE CONTRACTOR:** The Contractor shall perform no less than 51% of the Work, excluding Specialty Items, with its own organization. Specialty Items will be identified on the Bid Form.
